**Q1.** Based on your visits to Montgomery County Public Schools, an early childhood center (or your experience as an MCPS substitute teacher or paraeducator), discuss two specific areas where you witnessed teachers who excelled in meeting students' needs and explain why.

**Q2.** What are two of the biggest challenges teachers face to implement effective instruction in early childhood classrooms and settings? Where do you see opportunities for increased teacher quality and preparation?

**Q3.** ECACP strives to prepare effective teachers. The program is rigorous and accelerated with fast-paced coursework and intensity in collaboration, assignments and assessments.
