Organizational Changes

Cassandra Jones announced that assessment now reports to Academic Affairs.

General Education

- The CAT reviewed the CYCLE B summary report and suggested placing it online so that all faculty could see the results. Cassandra Jones shared with the group that they reviewed 59 course reflections last fall from CYCLE B.
- The number of courses, students and sections that were assessed in fall 2014 (CYCLE C) were announced:
 - o Number of courses assessed: 42
 - o Number of students assessed: 6,372
 - Number of course sections assessed: 455

Program Assessment Deadline Changes

Announcement and Questions

Cassandra Jones distributed the CYCLE C assessment schedule for this semester and encouraged faculty to share as necessary. Alla Webb asked about next steps in the program assessment schedule. Cassandra Jones stated that she would give her the form to complete.

General Education Data and Interpretation Guidelines

Cassandra Jones distributed sample results from a General Education Assessment Course. The faculty examined the results, developed questions to guide faculty with reviewing the data, suggested ideas for what type of information would be helpful for making sense of results. The faculty had the following suggestions:

- 1. Provide an overview of the assessment process. Including a screen shot of how data were entered.
- 2. Give instructions on how to read and interpret the handouts/results
- Provide guiding questions. Topics for the questions include: a) changes in assessment instrument and b) focus on student learning performance and c) suggestions for developing next steps.
- 4. Give examples for how grade distribution could help
- 5. Provide distribution by student major
- 6. **Provide information on student English and reading levels (ACCUPLACER results)**

Communication with faculty community about assessment

Cassandra discussed the idea of having a general session on assessment at Montgomery College. The faculty suggested that in addition to the overall session, there be a session entitled "Assessment Lab" where faculty could come and Cassandra would help with their assessment reports. It was also suggested that a session on assessment be conducted during chair training.

Review of Assessment Activity

 General Education Assessment – The group discussed the types of data reports that are received for General Education assessment. There was a consensus that future reports should contain gender and ethnicity data. There was also a discussion about viewing results by the type of course (e.g. OER or Z-course). Unfortunately, not all courses with these designations are identified in the College's database, making it difficult to obtain this information.

Tk20 Updates/Other updates

- Cassandra announced that TK20 will be used for General Education Assessment Reflections, DFW collections.
- The group viewed the information in the Dropbox for General Education Results. For future reflections, they suggest incorporating into the Reflection Sheet the suggested action statements.

Assessment Plan Reviews

- ASL Solid plan– should proceed
- Paralegal Plan needs revision
- General Studies Plan can proceed, but would be stronger with different assessment plans for the different degrees within General Studies
- Photography Solid plan should proceed

Based on discussion, programs should provide explanation for benchmarks given in plan
